Proposed Plan Change H(b): Notable Trees Clarification

In November 2022 the Manawatū District Council notified and formally called for submissions on changes being proposed to the Manawatū District Plan about notable trees. The Plan Change is known as Plan Change H(b): Notable Trees (PCH(b)). PCH(b) reviews the existing list of notable trees in the District Plan and recommends changes to the schedule of notable trees. A new chapter is also added which outlines what can be done to notable trees and the surrounding land with and without the requirement of a resource consent.

The Council has received a submission relating to Plan Change H(b): Notable Trees to the Manawatū District Plan in relation to the notable tree (*Sequoiadendron giganteum*; Wellingtonia/Giant sequioa) located at 28 Kimbolton Road, Feilding. The submission has been lodged by Geoworks on behalf of Adrian and Clare Hare. Within the submission you are listed as a 'concerned neighbour'.

What is not clear is whether you are a joint submitter (and agree with all the statements in the submission), or are just concerned about the plan change given the proximity of your property to the notable tree. We have noted that you have not provided your signature to the submission. For the purpose of the future plan change hearing and to assist the hearing panel, we would like to clarify if you are party to the submission that has been lodged by Geoworks (i.e. you support all statements made).

I have attached the submission that Council has received for your information.

Good afternoon Joan

Thank you for your guick response (sorry for the incorrect date on the letter, my mind was still in 2022!).

The Resource Management Act (RMA) requires some important procedural steps that relate to the service of submissions in a plan change process. The next step in this plan change process is for the council to call for 'further submissions', where people who are affected by the original submission can make a further submission in support or opposition to the original submissions. If a further submission is made, that further submitter must serve a copy of the further submission to the person who made the original submission within five working days of lodging the further submission with the council.

The hearing panel who will consider and make a decision on the plan change will also need to know who the submitters are.

For clarity, can you please confirm if you:

- 1. Would like to be included as submitters to the submission lodged for Clare and Adrian Hare;
- 2. Prefer to remain a 'concerned neighbour' (we can add your email to the section in my planning report which discusses the concerns raised in submissions without you being considered a submitter); or

Good morning Rochelle

John and I have today received your letter of 7 February 2022 (sic).

We were not involved with the preparation of the Geoworks submission. Nevertheless I have sympathy with the concerns expressed in that submission.

I understand that our home at 5 Pines Court is not likely to be directly affected by the Notable Tree falling. Nevertheless I have safety concerns in regard to the impact on neighbouring persons (with the potential for actual loss of life) in the event of the tree falling on those properties which would be directly affected.

In summary, whilst the ongoing falling debris is constantly creating a mess to the entrance of Pines Court, it is the potential for risk of injury/loss of life to anyone in the vicinity at the time of the tree falling which must be of the main concern/importance.

The recent weather events in Auckland during/after the heavier rainfalls demonstrate that there can be no complacency in regard to large trees in an urban setting.

Following on from our phone conversation in January, I have attached for your information a copy of the submission that was lodged by Geoworks on behalf of Clare and Adrian Hare in relation to the notable tree (Sequioadendron giganteum) at 28 Kimbolton Road.

In the submission, you will see that there is a list of 'concerned neighbours', including yourself.
We are in the process of confirming if the concerned neighbours wish to be considered as a submitter as part of that submission, or do not wish to be part of the submission but may just be a concerned neighbour.
This is important for the next stage of the process when the Council calls for 'further submissions' on the submissions that have been made, because any 'further submitter' will need to serve a copy of their further submission on the person who made the original submission within five working days of lodging the further submission with the Council. Also, the Council will need to let the Hearing Commissioners know who the original submitters are at the plan change hearing.
During our phone call in January, you indicated that you were neither in support or opposition to the notable tree (Sequioadendron giganteum) being included on, or removed from, the notable tree schedule, and that you did not wish to be a submitter.
Would you be able to confirm whether you still wish to not be included as a submitter as part of this submission.
