

**PUBLIC NOTICE UNDER CLAUSE 7 OF THE FIRST SCHEDULE OF THE RESOURCE MANAGEMENT ACT 1991
OF THE AVAILABILITY OF THE SUMMARY OF DECISIONS REQUESTED IN SUBMISSIONS TO:
PROPOSED PLAN CHANGE H(a) – HISTORIC HERITAGE
PROPOSED PLAN CHANGE H(b) – NOTABLE TREES**

Manawatū District Council is calling for Further Submissions on Proposed Plan Changes H(a) and H(b). The Council received six original submissions to Plan Change H(a) and four original submissions to Plan Change H(b).

A Further Submission provides the opportunity to submit in support or opposition to the submissions already received, to comment on how a submission may impact you, and to have your views heard alongside the original submission. The scope of a Further Submission is limited to support of, or opposition to, a submission already received.

Plan Change H(a): Historic Heritage [PC H(a)]

PC H(a) provides a review of the heritage items listed in Appendix 1E – Buildings and Objects with Heritage Value, excluding Marae Buildings. A new heritage schedule (Historic Heritage: Schedule 4b) is proposed, alongside new policies, rules and standards for inclusion into the Manawatū District Plan.

Plan Change H(b): Notable Trees [PC H(b)]

PC H(b) reviews Appendix 1D – Trees with Heritage Value and inserts a new Notable Trees Chapter and Notable Trees Schedule into the Manawatū District Plan.

Making a Further Submission

Further Submissions must be in writing in the form prescribed (Form 6) in the Resource Management Act 1991 or similar, including Further Submissions via email. Further Submissions lodged by way of email do not require a signature. IMPORTANT: Any person making a Further Submission on Plan Changes H(a) or H(b) must serve a copy of their Further Submission on the person who made the original submission within five working days of lodging their Further Submission with the Manawatū District Council.
