## POSITION STATEMENT OF HERITAGE NEW ZEALAND POUHERE TAONGA REGARDING PLAN CHANGE H(a)

- 1. Heritage New Zealand Pouhere Taonga (HNZPT) made a submission and further submission on Plan Change H(a). HNZPT was also involved with pre-hearing discussions with Manawatū District Council staff.
- 2. We have now had the opportunity to review the 42A report for the hearing and consider our position on a number of aspects of the plan change.
- 3. Regarding the scheduling of the Mangaweka Bridge, we have come to the conclusion that including this structure in schedule 4b as part of Plan Change H(a) is out of scope of the plan change.
- 4. As such, HNZPT will not be pursuing the bridge being included in the District Plan as part of this plan change.
- 5. We also note the recommendation that the bridge be scheduled in a future plan change, potentially as a joint plan change with Rangitīkei District Council. Heritage New Zealand Pouhere Taonga would obviously be interested in being a party to any future plan change.
- 6. It may also be of interest to the hearing that the inclusion of the Mangaweka Bridge in the New Zealand Heritage List / Rārangi Kōrero is being actively pursued. It is anticipated that the bridge will be included in The List before the end of this year.
- 7. Regarding the proposed amendments to HH-P11, HNZPT agrees with the comments in the 42A report that relocation is preferred to demolition as a heritage outcome. We also agree with the author that the amendments to HH-P11 add clarity to the policy and will be likely to achieve a better outcome, particularly regarding the choice between demolition and relocation.

- 8. I have also viewed the email from Rochelle Waugh dated 29 May 2023 in which she suggests alternative wording for HH-P11. Heritage New Zealand is neutral with regards to the alternative wording of HH-P11 recommended in the 42A report, and the version suggested by Rochelle in the email of 29<sup>th</sup> May.
- 9. As the main issues in contention with regard to HNZPT's submission appear to be agreed or resolved, HNZPT will not be appearing at the hearing, and will not be presenting expert evidence.

## 1. Outline of Position of S.M and J.M O'Brien Trust

- 5.M and J.M O'Brien Trust ('The Trust') made a submission on Manawatū District Council's Proposed Plan Change H(a) Historic Heritage (PPC H(a)). The primary focus of the submission was on Rule HH-28 and Policy HH-P11.
- 1.2 We have since read the further submission on Plan Change H(a) by Heritage New Zealand Pouhere Taonga ('HNZPT'); and, the Section 42A Report for Manawatū District Council prepared by Ms Rochelle Waugh.
- 1.3 Following the release of the Section 42A Report, the Trust's Consultant Planner (Mr O'Leary) since engaged in pre-hearing discussions with Ms Waugh. Both Mr O'Leary and Mr Dean Raymond for HNZPT) were provided with an email, dated 29 May 2023, which signals further amendments to Policy HH-P11, as detailed below:

## Policy HH-P11

To only allow relocation of heritage items listed in Schedule 4b where it can be demonstrated that:

- a. The relocation is necessary to save the heritage item and protect the heritage values from the threat of, or damage from natural hazards; or
- b. The relocation will protect the heritage values and significance of the heritage item, as confirmed by a suitably qualified heritage expert.
- 1.4 The Trust is neutral to the amended text above to be recommended by Ms Waugh. The Trust has therefore decided not to present any further expert evidence on this matter. The Trust also understands that NZHPT are also of that same position.
- 1.5 The Trust confirms that they still wish to speak to its submission.
