

# APPLICATION FOR EXTENSION OF TIME

## HOW IT WORKS

You need to start your building work within 12 months of receiving your building consent, or your consent will lapse.

If you need an extension, talk to Manawātū District Council before the 12-month timeframe is up. If the consent has lapsed and you still want to do the work, you will have to re-apply for consent.
